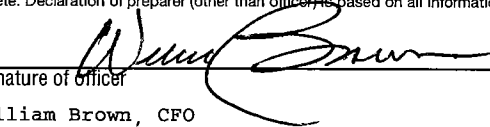
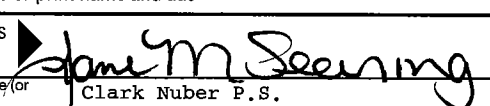

Strengthen 23,000 caregivers to support 150,500 OVC affected by HIV/AIDS in Kenya, Haiti and Zambia. Increase the capacity of 1,400 older children to meet their own needs. Ensure access to vocational and formal education for 3,600 OVC.

Haiti Earthquake Response (HEAR): Following the devastating earthquake of January 12, 2010, WCDO immediately began early recovery efforts for families within areas of Port-au-Prince who suffered catastrophic personal and material losses. The program aims to enable individuals and families to stay on their own land by providing cash-for-work activities (clearing rubble), shelter materials and building and house repair assistance.

Haiti Palliative Care, Orphans and Vulnerable Children, and Prevention (POP): WCDO, in partnership with six other organizations provided comprehensive community and faith-based responses to HIV/AIDS in Haiti. This program promoted HIV prevention messages and provided further support to communities.

Self Reliance in Eastern Chad (SREC): Finished a 3-year program which provided training, seeds and tools for internally displaced people and host communities to plant dry-season crops. Other project activities included cash-for-work, erosion control and reforestation efforts.

Haiti CHAMP: WCDO and its implementing partners are facilitating family, church and community efforts to provide support to people living with HIV and AIDS. Some of the activities include promotion of voluntary testing for HIV, education on nutrition and hygiene, and distribution of water-purified products and mosquito bednets for pregnant HIV positive women and children under 5.

Kenya Water and Sanitation: Three-year program to promote sustainable water supply and water systems in the semi-arid Narok and Lamu districts of Kenya. The program includes construction of rooftop rainwater catchment systems, djabias, drip irrigation systems and water pans along with training in sanitation and hygiene and construction of latrines.

Somalia Jubba Valley Community Water Project: Three-year program which improved access to and the quality of potable water for human consumption, while increasing community capacity to manage and maintain those water resources. Built or rehabilitated a total of 67 wells and 21 water pans, constructed 180 latrines, provided fishing kits for 11,000 families and established demonstration gardens for 300 farmers.
