SUMMERBREAK DAY CAMP PAYMENT

Pre-payment is required for all non-King's families by registering online.

Billing is handled through King's Business Office at the end of each month for King's families.

ACADEMIC, ENRICHMENT & SPORTS CAMPS PAYMENT

Register online. Full payment for camps is due upon registration.

PRIVATE MUSIC LESSONS PAYMENT

Registration and payment are arranged by music teachers.

CONFIRMATION

Your registration will be confirmed by email. To fully prepare you and your child, your family will receive an email with program information shortly before the program begins. Please provide us your email address.

REFUND POLICY

Refunds are provided only in the event of class cancellations.

TRANSFER POLICY

To transfer from one registered week to another we must receive the request at least 10 business days before either week begins. Refunds are not given on transfers and any balance must be paid in full at the time of the transfer. Payment on a transfer may not be applied to extended care fees. Full refunds and/or transfer options are given when we must cancel a camp.

BEHAVIORAL GUIDELINES

Families must abide by all King's Schools policies and guidelines. Parents are expected to help their campers follow all guidelines.

ACADEMIC AND ENRICHMENT CAMP SIZE

Academic and Enrichment Camps generally have a minimum of 8 and a maximum of 12 campers enrolled unless otherwise stated.

SPORTS CAMPS WAIVERS REQUIRED

All campers enrolled in Sports Camps must have signed waivers before participating in Sports Camps. Our online registration requires a waiver to process.

SCHOOL-AGE DAY CAMP

SummerBreak begins at 9:00 a.m. and ends at 3:30 p.m. Daily attendance is logged though the sign-in/out sheets located in the Elementary cafeteria at the SummerBreak desk. Non-King's families must pre-pay for SummerBreak either through online registration or by check by the first day of camp. King's families will be billed for SummerBreak fees through the business office at the end of the month.

BEFORE AND AFTER CAMP EXTENDED CARE

Cost of care is \$7.00 per hour per child. The school-age before care program opens at 6:30 a.m. and the school-age after care program closes at 6:00 p.m.

The extended-day child care program is a drop-in program. It is logged through the daily sign-in/out sheets located in the Elementary at the SummerBreak desk.

King's parents will be billed for all extended-day child care fees through the business office at the end of the month. Non-King's parents pay daily for care.
